I have read and agree to be bound by the General Competition Rules of Motorsport South Africa, hereinafter referred to as MSA, and I agree to be bound by the Supplementary Regulations issued for any competitions and / or events in which I take part. I agree that neither MSA, nor the Promoter, Organizer, Guarantor and / or Sponsor of any competition or the owner/s of the property on which a competition is held, nor any Government, Provincial or Municipal Body, and their respective officials, agents, servants or representatives shall be liable under any circumstances for any damage done by any vehicle entered by or ridden in or attended upon by me in any competition or for any personal injury – fatal or otherwise – or loss of whatever kind sustained by myself or any person riding in or attending upon it or any person whatsoever, whether caused during any competition or any practice run, or while the said vehicle is on any road or area forming part of the track or route or any deviation there from or any approach by whatever means such damage, injury or loss may be caused, and even through the same may be contributed to or caused by the wilful act, neglect or default of any official, agent, servant or representative of MSA, or any Promoter, Organizer, Guarantor or Sponsor of the competition, or the owner/s of the property on which the competition / event is held or any Government, Provincial or Municipal Body.

I hereby indemnify MSA, the Promoter, Organizer, Guarantor and Sponsor of the competition / event and the owner/s of any property on which the competition is held and any Government, Provincial or Municipal Body and their respective officials, agents, servants and representatives against any Legal Liability for any damage or injury so done or sustained as aforesaid by myself or any other such persons as aforesaid. I further declare that I am aware of the risks, dangers and perils attendant upon motorcar / motorcycle racing or rallying or any other form or motoring competition, which I hereby assume.

I further indemnify all associations and their member clubs and all clubs affiliated to MSA, all hereinafter referred to as the Regularity Bodies and any Official, Representative, Promoter, Organizer, Sponsor, Guarantor organizing any event, outing or function, the owner/s of any property in or upon which the event, outing or function is held and any Government, Provincial, Regional Services Board or Municipal Body and their respective agents against any Legal Liability for any damage or injury that may arise during my participation in an event, outing or function organized by the Regularity Bodies and persons described herein.

This indemnity shall apply to all events, outing and functions, nothing excluded, arranged, staged or organized by the Alfa Romeo Club of Pretoria and persons named herein whether individually or as a group.

I further accept full responsibility for obtaining, and providing to the Alfa Romeo Club of Pretoria, prior to any event, indemnity declarations from any persons who accompany me in, or on, any such event, failing which I accept full liability for such persons.
